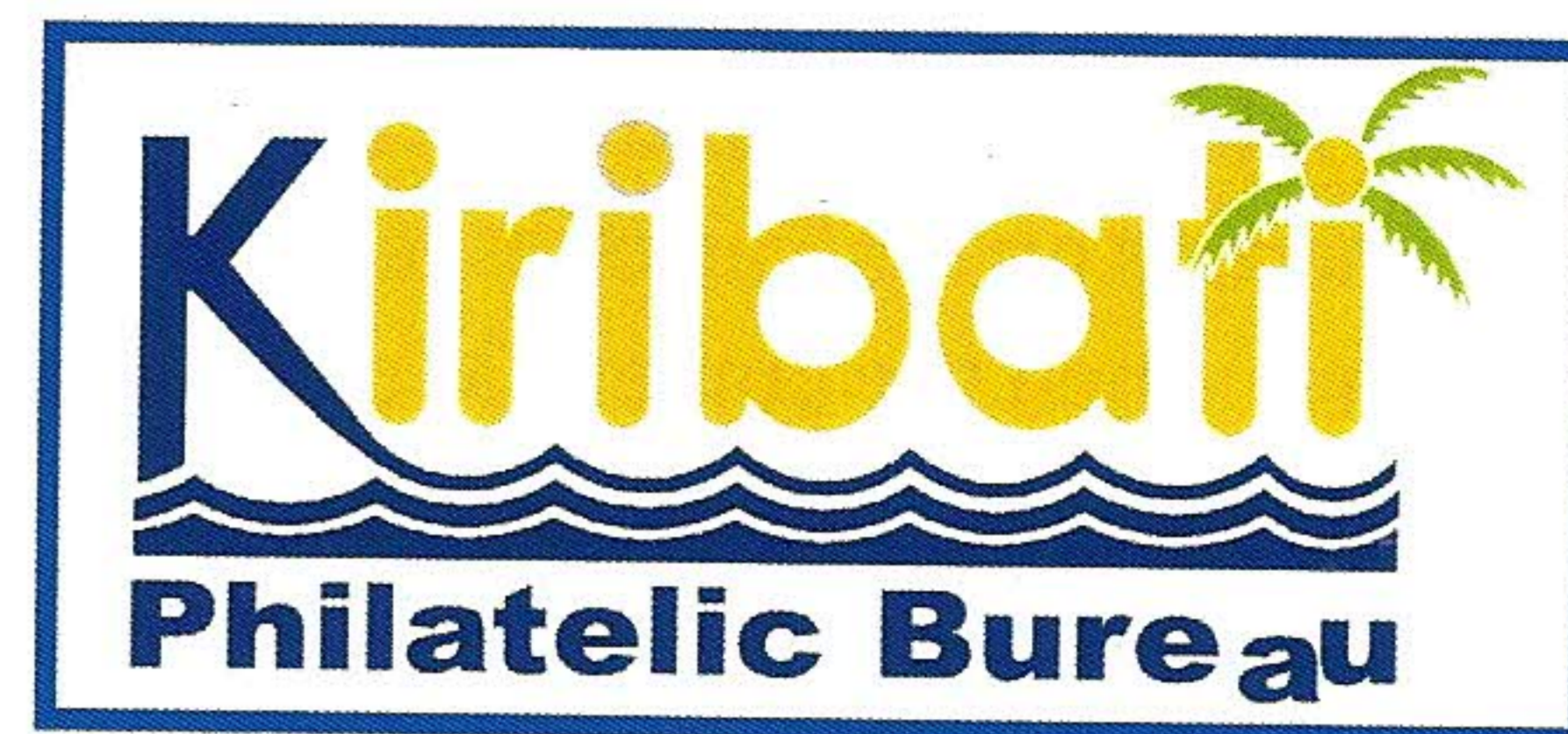


## Kiribati - News for Bureau Account Holders.

### INCREASED BANK FEES ON FOREIGN CHEQUES

New Year Greetings to you all!

It is with great regret to inform you that the Bank of Kiribati (the only bank in the country) has recently advised of the increased fees to be imposed on foreign cheques. The fees will be so high based on the 'send on collection' service which will require the cheque to be returned and endorsed from its original bank before the bank here can process it.

To escape such fees, the Kiribati Philatelic Bureau (KPB) wishes to inform you that we will temporarily ceased accepting foreign cheques as payment of stamps effective from 1 January 2014. We wish to encourage you to send stamp payment instead either by bank notes, bank telegraphic transfer (TT) or Western Union as the fees will be much cheaper compared to the fees incur on foreign cheques.

We regret for any inconveniences caused and assure you of our attention and best service at all times.

The canceller, it does not appear to be a datestamp and is therefore almost certainly an "Official" handstamp also, and somewhat unusually, has Marakei Island within the outer rings, and has a manuscript 31/12/13 date added.

### New Hebrides - The Bill Holland Estate.

By agreement with his family Bill Holland's New Hebrides collection will be sold by auction, many of the most significant items being handled by David Feldman (Auctioneers), as indicated by the advertisement in this issue of Pacifica.
