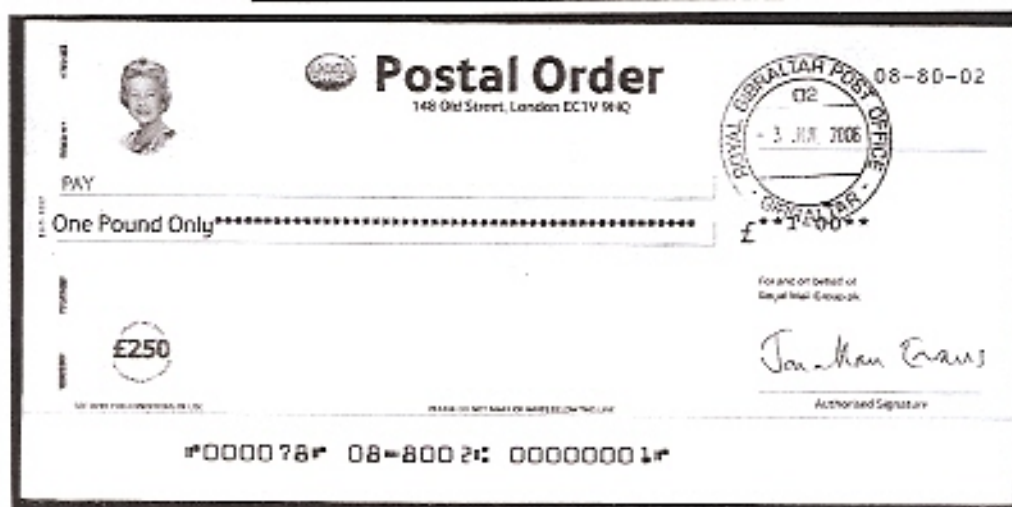
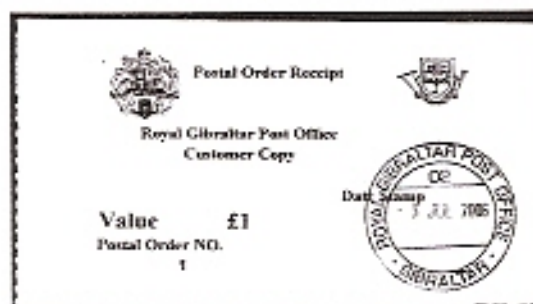
This is a follow up of the article, which appeared in the last PON. I now have information from six more countries, which are as per Table 2.

SV	Standard Value Issued in UK with min. value of 50p and max of £250. Details of the value (in words and figures), and date are computer printed. Will also print the payees details and cross the order upon customer's request.
LV	Limited Value Issued in Guernsey & Jersey with min. value of 1p and max of £9.99. I.O.M with min. value of 50p and max. of £9.99 and BFPOs. Postal orders overprinted "VALUE NOT TO EXCEED £9.99". Details of the value, date and payee are handwritten.
FV	Fixed Value Issued by overseas countries listed on Table 2.
SNP	Serial Number Prefix This is the six digit numbers located on the bottom left hand corner of the postal order Eg. 000010 (in short 10)
