Dear Steve,

As promised, I finally put together a roughly 40-lot Mail Sale of PNG material for one of your future NEWSLETTERS. What a job!!! I still have a long ways to go to reduce my PNG collection to manageable size.

The lots are listed in manuscript and await typing, depending on what format you'd like me to use.

I can type it up on typewriter and send to you for your word processor (you'd have to redo) or I can try it on mine and send you a disk (I use Microsoft Works for Windows) Or I can print it out for you on 8½ x 11 paper.

The main question is: can you tolerate more detail such as I use for the SAS/O Mail Auction lists? I send Hugh Wynn the typed copy and he formats it for the INFORMER. Describing some lots, especially multi-items, takes up space. Yours have been simpler.

I can do whatever you want, depending on your available time and timing. Let me know via the enclosed SASE.

Enclosed is a ham radio QSL from 1947 I found in my excess PNG junk and some soaked off registration labels from other than PNG. Maybe you can find a home for them. I'm entering some PNG labels off covers in the above 40 lots plus many on cover.

PS: I've also enclosed copies of 4 sheets of registration labels put together by early PNG collector Paul Miller, who died in the 1970's. I may have added some. I can't recall the identification, whether one is Henk Tenis and the other from the monograph you got from the last SAS/O Auction (D.R. Taylor). I was really into this at one time but gave it up. Maybe these should be in a future auction. Perhaps the copies will be of value if you or Henk publish anything.

One other point: I can keep the Lots and mail them to winning bidders or I can send you all the lots for you to mail out (if you are combining other material with mine). Another possibility is for me to be the "auctioneer" and be listed as the person to whom bids are sent -- that way, I do the mailing also (what I do for Bonnie on the SAS/O auctions I handle. *van*)
